COMES NOW the Office of Superintendent of Public Instruction (OSPI), under the authority granted by the laws of the state of Washington, having reviewed the file of the above-referenced case, and having considered the entire evidence contained therein, does hereby stipulate by and between the Office of Professional Practices (OPP), OSPI, and Ronald D. Stainbrook, that Ronald D. Stainbrook shall be reprimanded based on the Findings of Fact and Conclusions of Law set forth below:

## FINDINGS OF FACT

1. Ronald D. Stainbrook was issued a Washington education certificate, No. 275633F, on October 14, 1999. This certificate currently remains valid.
2. Ronald D. Stainbrook was employed by the Franklin Pierce School District.

3. On May 31, 2000, the Office of Professional Practices, OSPI, did receive a complaint letter alleging a lack of good moral character or personal fitness, or a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) 180-87, by Ronald D. Stainbrook.

4. On November 9, 1999, Chad Lee, a former coach at Washington High School, met with Principal James Ridgeway regarding concerns Chad Lee had with Ronald D. Stainbrook's inappropriate relationships with female students.

5. Effective November 19, 1999, Jamie Siegel, Executive Director of Human Resources, placed Ronald D. Stainbrook on administrative leave with pay for alleged inappropriate physical contact with female students and maintaining uncomfortable proximity with students.

6. On May 22, 2000, Ronald D. Stainbrook signed a resignation agreement with the Franklin Pierce School District.

7. Good moral character and personal fitness is a requirement to maintain a Washington education certificate.

#### CONCLUSIONS OF LAW

1. OSPI has jurisdiction over Ronald D. Stainbrook and over the subject matter of this action.

2. OSPI has shown by a preponderance of the evidence that Ronald D. Stainbrook should be reprimanded as provided for in WAC 180-86-065.
3. Ronald D. Stainbrook has violated WAC 180-87-060.

ORDER

THEREFORE, it is hereby ordered and agreed that Ronald D. Stainbrook be reprimanded and ordered to not continue or repeat the conduct described in the above Findings of Fact and Conclusions of Law.
