CERTIFICATION OF PROBABLE CAUSE

DENNIS A. JONES,

JODILYN A. ERIKSON-MULDREW, Deputy Prosecuting Attorney for Thurston County, declares the following in support of probable cause for charges in the above-entitled cause:

I am a Deputy Prosecuting Attorney for Thurston County, Washington and I am familiar with the police report(s) and investigation conducted in this case. Based upon information provided through that investigation there is probable cause to believe that the defendant committed the crime(s) SEXUAL MISCONDUCT WITH A MINOR IN THE FIRST DEGREE - 5 COUNTS, FURNISHING LIQUOR TO A MINOR ONE COUNT as supported by the following facts and circumstances:

DOB: 6/17/83
According to reports, on 5/6/02 Olympia Police Detective Steve Gallagher received a phone call from [REDACTED] requesting that he meet with her. On May 7, 2002 Detective Gallagher met with [REDACTED] [REDACTED] told Detective Gallagher that she had been sexually intimate with her soccer coach Dennis Jones. Dennis Jones was the Black Hills Football Club soccer coach for the team [REDACTED] played on. Over a period of time she began trusting Dennis Jones and eventually they became sexually intimate. The first physical contact he had with her was at a soccer tournament in Bellingham in the summer of 1998. [REDACTED] was 15 years old at that time. This eventually developed in to a more serious relationship in which they had sexual intercourse many times over a period of approximately one year or more. [REDACTED] told Detective Gallagher that in July/August of 1999 she and David Jones had oral sex at his apartment located in Olympia. She said that they had oral sex again and then actual sexual intercourse at his apartment in September/October of 1999. She told Detective Gallagher that she and David Jones had sexual intercourse on this occasion and on a regular basis from September/October, 1999 until the fall/winter of 2000. [REDACTED] also indicated to Detective Gallagher that David Jones bought her beer and hard alcohol on numerous occasions. The defendant, David Jones was arrested on Friday, May 17, 2002 for five counts of sexual misconduct with a minor in the first degree and one count of furnishing liquor to a minor.
