Dear Mr. Rorick:

Pursuant to your request of the 17th of May, 1994, investigation and surveillance was initiated and conducted on May 18th, 1994 relating to the activities of teacher Randy Hammack and student [REDACTED]

A summary of that activity and the results are as follows:

- On May 18th, 1994 at 1:00pm information identifying the teacher and student to include vehicles, residences and work locations was obtained.
- On May 18th, 1994 at 2:15 p.m., surveillance was in place at the residence of Mr. Hammack. That location being the Country Glen apartments at SE 274 and 132 SE, specifically apartment #206.
- On May 18th, 1994, at 2:29p.m., student [REDACTED] was seen arriving at the residence driving her red Honda, WA License [REDACTED]. She parked her vehicle in a space in front of the apartment building and was seen entering the stairwell leading to unit #206.
- On May 18th, 1994 at 3:36p.m., teacher Randy Hammack was seen arriving at his residence, driving his white Jeep Cherokee, WA License 795-EFF. Mr. Hammack was seen parking in a space to the south of his building. He exited the vehicle carrying what appeared to be two sacks of fast food (burgers?) and two cold drinks. He went straight to the stairwell of his apartment and was seen entering.
- On May 18th, 1994 at 4:39p.m., Mr. Hammack and Ms. [REDACTED] were seen exiting the stairwell of Mr. Hammack's unit together. They were seen kissing and embracing. Ms. [REDACTED] removed a dark back pack from her parked vehicle. They both then walked to Mr. Hammack's vehicle where they again embraced and kissed. Ms. [REDACTED] got into the Jeep behind the wheel and Mr. Hammack was seen giving what appeared to be operating instructions. Mr. Hammack was seen to "write" on the windshield with his finger what appeared to be the words "I love you". Ms. [REDACTED] responded in sign language with "I love you." She then started the vehicle and drove off through the

north exit of the complex as Mr. Hammack returned to his apartment. Ms. [REDACTED] was given a lead as it was believed she was enroute to work in Kent.

- On May 18th, 1994 at 5:00pm a drive through was made at the Sub Shop at 136 Washington in Kent where Ms. [REDACTED] works after school. The Jeep she was last seen driving was not in the lot. Surveillance was terminated at that time.

The results of this investigation and details were reported to your office the morning of the 19th of May.

If further documentation and evidence relating to this matter is required, please advise.
