Comes Now Dr. Michael P. Stefanic (hereinafter Complainant), as Chief Certification Officer of the State Board of Education (SBE), pursuant to Idaho Code §§ 33-1208 and 33-1209 and the provisions of Title 54, Chapter 23, Idaho Code, files this Administrative Complaint against Respondent Steve Milionis (hereinafter Respondent) and complains and alleges as follows:

**JURISDICTION**

**I.**

That Respondent's last known address was North 9509 Reed Road; Hayden Lake, Idaho, 83835.

**II.**

That Respondent was issued and holds an Idaho Teaching Certificate which expires September 1, 2000.

### III.

That on or about March 12, 1998, the Executive Committee of the Professional Standards Commission (PSC) found sufficient grounds existed to believe that Respondent has violated the Code of Ethics of the Idaho Teaching Profession and Idaho Code.

### COUNT I

#### IV.

At all times relevant hereto Respondent was a teacher in Wallace School District #393.

#### V.

During the academic years 1985 through 1989, Dody Ann Stewart (hereafter referred to as "Stewart") was a student at the Silver Hills Middle School and Wallace High School, School District #393

#### VI.

In 1985 Stewart, age fourteen, was a ninth grade student in the Wallace School District. At or about that time Respondent stated to Stewart that he had personal feelings for her. Respondent engaged in sexual relations with Stewart on various occasions between the fall of 1985 and the spring of 1989 while employed by the Wallace School District.

#### VII.

That Respondent's conduct enumerated in Count I is in violation of the Code of Ethics of the Idaho Teaching Profession and Idaho Code as set forth below:

Principle I (2) - Shall protect the student from conditions detrimental to learning or to physiological or psychological well being.

Principle I (6) - Shall refrain from using professional relationships with students for

personal advantage.

**Principle III (8) – Shall not engage in conduct which is offensive to the ordinary dignity, decency, and morality of others.**

**Idaho Code § 33-1208 (1) (j) - Wilful violation of any professional code or standard of ethics or conduct, adopted by the State Board of Education.**


**PRAYER FOR RELIEF**

WHEREFORE, Complainant prays for relief pursuant to Idaho Code §33-1209(7) and for such other relief as may be just and equitable.

**DEFAULT**

In the case of default for failure to file an answer to this complaint and request a hearing within thirty (30) days from the date of service of this complaint, all allegations will be deemed to be admitted and Respondent's teaching certificate shall be revoked.
